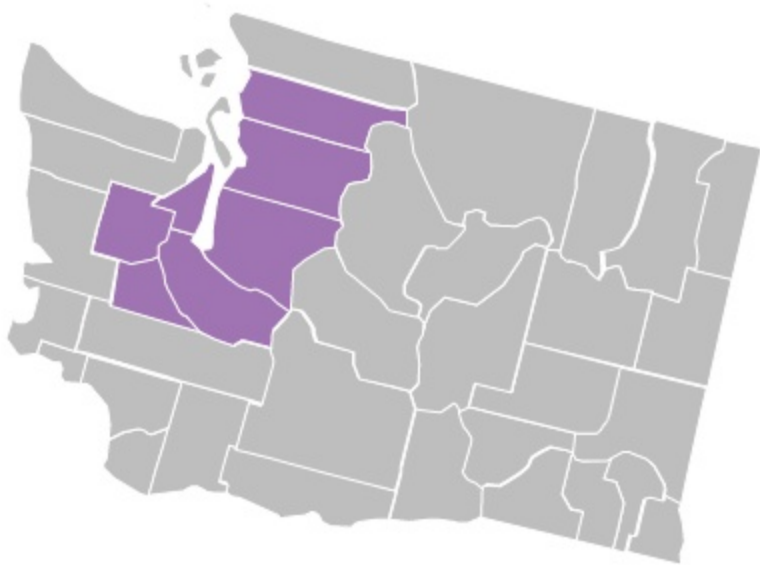


Washington highlights

- NEW: Puget Sound Elite HMO with a \$2,000 dental allowance for preventive and comprehensive service, no deductible and no waiting period, plus:
 - \$2,000 hearing aid allowance per ear
 - \$35 specialist copay
 - \$10 copay for both naturopathic (6 visits) and routine chiropractic services (12 visits)
 - No Rx deductible for all five tiers
 - \$0 copay tier 1 and \$5 copay tier 2 at preferred pharmacies
- For Puget Sound, a range of plans including HMO Value Plus, Platinum Plus, HMO Prime and Elite; as well as traditional PPO and a new \$0 PPO MA-only plan
- Introducing \$0 Elite HMO plans in Spokane, Clark and Cowlitz counties
